Ready. Set. Retire: Thinking of retiring? Come hear from Retirement, Benefits and Deferred Compensation professionals to get your questions answered.

*The Office of the Labor Commission will grant non-essential employees three (3) hours of permission leave, including travel time, to attend one (1) seminar. Provided that City operations are not adversely impacted, supervisors may also grant essential employees permission leave to attend one (1) seminar. Supervisors should coordinate schedules to provide adequate coverage and avoid disruption to City Services.
